### **I. Introduction to Sundial**

Sundial is a digital solution provided to you by Sundial Labs, LLC (“Sundial Labs”), a wholly owned subsidiary of State Farm Mutual Automobile Insurance Company (“SFMAIC”).

Sundial uses the Sundial mobile application (“Sundial Application”) and optional

Sundial Skill for Amazon Alexa (“Sundial Skill for Alexa”) (together, the “Sundial Services”) to help you stay connected, interact, and share information with the important people in your life (“Care Circle”).

You may discontinue your use of the Sundial product at any time by removing the Sundial application from your device. Sundial may archive your user information and all related usage data, in accordance with our Privacy Policy, at any time.

## **II. Sundial Terms of Service**

These Terms of Service (“Terms”) govern your access to and use of the Sundial Services and are a binding agreement between you and Sundial Labs. You should carefully read these Terms to make sure you understand them. You acknowledge and agree that, by accessing or using the Sundial Services, you are indicating that you have read, understand, and agree to be bound by these Terms. If you do not agree to these Terms, you do not have any right to access or use the Sundial Services.

You may choose to use the Sundial Services by using the Amazon Echo and Sundial Skill for Alexa; by accepting and agreeing to these Terms, you acknowledge and agree that you have reviewed, understood, and agreed to the Amazon Device Terms of Use (“Amazon Device Terms”).

## **III. Capacity and Consent**

You may not use the Sundial Services unless you have capacity to read, understand, and agree to these Terms. By accepting these Terms and using the Sundial Services, you are attesting that you have capacity to read, understand, and agree to these Terms, and that you are not the ward of a court-ordered guardianship, and have not been otherwise declared to lack mental capacity to enter into a contract by a court or physician.

You may revoke your consent at any time by deleting members from your Care Circle using the Sundial Skill for Alexa, the Sundial Mobile app, or by contacting Sundial Labs at 1-833-255-0228.

## **IV. Account Registration**

In order to access and use the Sundial Services, you must register to create an account. You agree to provide accurate, current and complete information during the registration process and to update such information to keep it accurate, current, and complete. Sundial Labs reserves the right to suspend or terminate your account if any information provided during the registration process or thereafter proves to be inaccurate, not current, or incomplete. As part of the registration process, you will be asked to create a password. You are responsible for remembering and safeguarding your password. You agree that you will not disclose your password to any third party and that you will take sole responsibility for any activities or actions taken through your account, whether or not you have authorized such activities or actions. If you become aware of any unauthorized use of your Account, you agree to immediately notify Sundial Labs at 1-833-255-0228.

## V. Eligibility

The Sundial Services are intended solely for persons who reside in the United States. You may not use the Sundial Services if you are not a resident of the United States.

You may not use the Sundial Services unless you are age 18 or older. Any access to or use of the Sundial Services by anyone under the age of 18 is expressly prohibited. By accessing or using the Sundial Services, you represent that you are at least 18 years old.

## VI. Connection to the Care Circle

As part of your use of the Sundial Services, you will share information with the members of your Care Circle. You may add an unlimited number of individuals to your Care Circle and may delete any member of the Care Circle at any time. No one may add members to or delete members from the Care Circle without your prior consent. You should carefully select the members of your Care Circle and limit the Care Circle to those people with whom you want to share your information.

**You should never share any sensitive personal information, including but not limited to medical and financial information, using the Sundial Services, and should not share any updates unless you want all members of the Care Circle to receive the updates.**

Any information you share with your Care Circle will be transmitted to, stored, and available on each Care Circle member's Sundial Application account. Sundial Labs does not monitor the information you share with your Care Circle. You are solely responsible for any and all information you share with your Care Circle; **any information you share with your Care Circle will be shared with and available to all members of the Care Circle.** You should not share any information unless you are comfortable with and consent to all members of the Care Circle receiving and having access to your information.

Sundial Labs will not be liable for any information you share with the Care Circle using the Sundial Services, or through permissions you grant on your mobile device, or any harm or injury resulting from the information you share with your Care Circle. Sundial Labs shall not be responsible or liable for any incidental, special, exemplary, or consequential damages arising from your use of the Sundial Services, or from the use of any information you share with your Care Circle. Sundial Labs does not view or monitor the content of photographs shared using the Sundial Services, and is not responsible for photographs shared using the Sundial Services. You agree that Sundial Labs will not be liable for any injury or damages arising from photographs shared using the Sundial Services, including but not limited to copyright infringement.

## **VII. No Medical Advice**

## **VIII. Use of the Sundial Skill for Alexa**

By enabling and using the Sundial Skill for Alexa, you are authorizing Sundial Labs to perform any and all actions requested through the Sundial Skill for Alexa. This may include Sundial Labs sharing information with your Care Circle, your Amazon Echo, and Amazon. Any and all interactions you have with the Sundial Skill for Alexa are facilitated through Amazon. These interactions may be recorded and used by Amazon in accordance with the Amazon Device Terms.

You hereby authorize Sundial Labs to collect, use, and store information related to your use of the Sundial Skill for Alexa. Information collected by Sundial Labs is subject to the terms set forth in the Privacy section, below.

Your use of the Sundial Skill for Alexa is voluntary. By enabling and using the Sundial Skill for Alexa, you agree to use the Sundial Skill for Alexa in accordance with these Terms. You further agree that you are solely responsible for any and all interactions and communications with the Sundial Skill for Alexa.

You may disable the Sundial Skill for Alexa at any time. If you disable the Sundial Skill and do not have the Sundial Mobile App, you will not be able to use the Sundial Services to connect to and share information with your Care Circle.

You agree and acknowledge that:

- Sundial Labs is not responsible for any errors caused by inaccurate information captured by the Amazon Echo during an interaction with the Sundial Skill for Alexa;
- Information you share through the Sundial Skill for Alexa will be transferred through and shared with Amazon;
- You are responsible for any charges associated with the Sundial Skill for Alexa;
- Sundial Labs disclaims any and all warranties regarding the Sundial Skill for Alexa, including any warranty that interactions with the Sundial Skill for Alexa will be error free or uninterrupted; and
- Sundial Labs shall not be liable to you for any indirect, consequential, incidental, or special damages (including, without limitation, loss or destruction of data) arising out of using the Sundial Skill for Alexa, regardless of the theory of liability.

## **IX. Privacy**

In addition to information you intentionally and voluntarily submit to Sundial in connection with your use of the Application and its features, by using the Application you acknowledge that Sundial may collect the following categories of information from you :

- Name
- Email address
- Phone number
- Physical address
- Coarse location
- Photos or videos
- Audio data
- Other user data such as list items, calendar entries, and plain text associated with memories
- User ID
- Device ID
- Crash data
- Other data types including but not limited to check-in data, survey responses, product setting, time zone

The information collected by Sundial may vary based on how you use the services within the Sundial Application.

By accessing and using the Sundial Services, or through permissions you grant on your mobile device, and by choosing to use Sundial Services, you consent to the collection, transfer, processing, storage, disclosure, and other use of your information described in the Sundial privacy policy, available at [www.Sundial-Labs.com/privacy/policy](http://www.Sundial-Labs.com/privacy/policy).

## **X. Modification**

Sundial Labs reserves the right to modify, discontinue, or terminate availability of the Sundial Services, or modify the Terms, at any time and without prior notice. You will be notified each time Sundial Labs modifies the Terms and will be required to review and agree to the modified Terms in order to continue using the Sundial Services.

## **XI. Ownership and License**

The Sundial Application and Sundial Skill for Alexa, along with any other content provided by Sundial Labs through the same, including trademarks, trade dress and copyrightable text (collectively, “Sundial Labs Content”), are protected by copyright, trademark, and other laws of the United States and foreign countries and are the proprietary designations of Sundial Labs. Any other

trademarks, service marks, logos, trade names and any other proprietary designations are the trademarks or registered trademarks of their respective parties. You acknowledge and agree that the Sundial Application, Sundial Skill for Alexa, and Sundial Labs Content, including all associated intellectual property rights, are the exclusive property of Sundial Labs. You will not remove, alter or obscure any copyright, trademark, service mark or other proprietary rights notices incorporated in or accompanying the Sundial Application, Sundial Skill for Alexa, or Sundial Labs Content.

Subject to your compliance with these Terms, Sundial Labs grants you a limited, non-exclusive, non-transferable license to use the Sundial Skill for Alexa, and to view, download, and print any Sundial Labs Content solely for your personal and non-commercial purposes. - Attempt to decipher, decompile, disassemble or reverse engineer any of the software used to provide the Sundial Services;
- Interfere with, or attempt to interfere with, the access of any user, host or network, including, without limitation, sending a virus, overloading, flooding, spamming, or mail-bombing the Sundial Services; or
- Encourage or enable any other individual to do any of the foregoing.

Sundial Labs will have the right to investigate and prosecute violations of any of the above to the fullest extent of the law. Sundial Labs may involve and cooperate with law enforcement authorities in prosecuting users who violate these Terms.

You acknowledge that Sundial Labs has no obligation to monitor your access to or use of the Sundial Services or to review or edit any of your information, but has the right to do so for the purpose of operating and providing the Sundial Services, to ensure your compliance with these Terms, and to comply with applicable law or the order or requirement of a court, administrative agency or other governmental body.

Sundial Labs reserves the right, at any time and without prior notice, to remove or disable access to any Account Content that Sundial Labs, at its sole discretion, considers to be in violation of these Terms or otherwise harmful to the Sundial Services.

#### **XIV. Termination**

If you violate these Terms, Sundial Labs has the right to suspend or disable your access to the Sundial Services, at its sole discretion and without prior notice to you. Sundial Labs reserves the right to revoke your access to and use of the Sundial Services at any time, with or without cause.

You may discontinue use of the Sundial Services and terminate your Care Circle's access to your information at any time by contacting Sundial Labs at 1-833-255-0228.

These Terms and any action related thereto will be governed by the laws of the State of Illinois without regard to its conflict of laws provisions. The exclusive jurisdiction and venue of any action to prevent the actual or threatened infringement, misappropriation or violation of a party's copyrights, trademarks, trade secrets, patents or other intellectual property rights, will be the state and federal courts located in the Central District of Illinois and each of the parties hereto waives any objection to jurisdiction and venue in such courts.

### **XIX. Entire Agreement**

These Terms constitute the entire and exclusive understanding and agreement between Sundial Labs and you regarding the Sundial Services, and these Terms supersede and replace any and all prior oral or written understandings or agreements between Sundial Labs and you regarding the Sundial Services.

### **XX. Assignment**

You may not assign or transfer these Terms, by operation of law or otherwise, without Sundial Labs' prior written consent. Any attempt by you to assign or transfer these Terms, without such consent, will be null and of no effect. Sundial Labs may assign or transfer these Terms, at its sole discretion, without restriction. Subject to the foregoing, these Terms will bind and inure to the benefit of the parties, their successors, and permitted assigns.

### **XXI. Notices**

Any notices or other communications permitted or required hereunder, including those regarding modifications to these Terms, will be in writing and given by Sundial Labs: (i) via email (in each case to the address that you provide); or (ii) by posting in the Sundial Application

or sending you notification via the Sundial Skill for Alexa. For notices made by e-mail, the date of receipt will be deemed the date on which such notice is transmitted.

## **XXII. Miscellaneous**

The failure of Sundial Labs to enforce any right or provision of these Terms will not constitute a waiver of future enforcement of that right or provision. The waiver of any such right or provision will be effective only if in writing and signed by a duly authorized representative of Sundial Labs. Except as expressly set forth in these Terms, the exercise by either party of any of its remedies under these Terms will be without prejudice to its other remedies under these Terms or otherwise. If for any reason a court of competent jurisdiction finds any provision of these Terms invalid or unenforceable, that provision will be enforced to the maximum extent permissible and the other provisions of these Terms will remain in full force and effect.
